Legal Review

- Purpose of 7-11 committee
 - Review a District site to determine the feasibility of using it more effectively and efficiently in pursuit of both fiscal sustainability and the realization of key District initiatives
- Meetings noticed, open to public and in compliance with Brown Act

7-11 Committee Configuration

- Under the Education Code, 7-11 Committees are appointed in connection with the lease or sale of excess real property "to advise the governing board in the development of district-wide policies and procedures governing the use or disposition of school buildings or space in school buildings which is not needed for school purposes"
- At least 7 members and no more than 11
- Purpose is to have community involved before decisions are made about school closure or the use of surplus space, thereby avoiding community conflict
- Reflect ethnic, age group, and socioeconomic composition of district; business community; landowners and renters; teachers; administrators; parents; environmental, legal, building code, land use expertise

7-11 Committee Duties

- Review projected school enrollment and other data provided by district to determine the amount of surplus space
- Establish priority list of use of surplus space and real property that will be acceptable to the community
- Circulate a priority list of surplus space and real property and provide for community hearings on acceptable uses of space and real property - via agendas and committee meetings
- Prepare and forward to the governing board a report recommending uses of surplus space and real property


Brown Act

- The 7-11 Committee is subject to the Brown Act
- Committee meetings must take place pursuant to a published agenda
- Definition of meeting: an assembling of a majority of committee members to discuss matters within the jurisdiction of the committee

Leadership Selection

Chairperson - will lead meetings
Vice Chairperson - will lead meeting in the Chairperson's absence

Staff Report - Purpose of the Development JUHSD is the Lowest Funded High School District on the Peninsula


Equitable access to educational resources

- Equity gaps persist for historically marginalized groups ethnicity, language and socio-economic status
- High needs for non-traditional educational supports
- High employee turnover
- Fewer opportunities for JUHSD students

Multipronged approach

- Passed two parcel taxes
- Employee housing





Staff Report - Method of Site Selection

- 2017-2018 Board holds site meetings - Overwhelming concern: ability to attract and retain staff, with low salaries as main problem
- Explored generating revenue from underutilized property (Oceana HS, Westmoor Park, Terra Nova HS, and Serramonte Del Rey)

- Serramonte Del Rey: site with best earning potential
- 6/4/19 Board vote (4-0): borrow funds (COP) for the entitlement process
- 7/9/19 Board vote (5-0): contract with Brookwood to lead entitlements
