

Purpose for Pursuing Development JUHSD is the Lowest Funded High School District on the Peninsula

If JUHSD received 165%

At 108% JUHSD received about \$49.7M

At 165%, JUHSD would have received over \$75.7M = \$26M more annually

For perspective,

- a 1% raise is about \$500K annually
- CTE teacher or a counselor costs about \$100K annually
- JUHSD spends about \$700K annually on athletics

Question of Surplus

JUHSD will be able to meet projected student need with other district property and adapt to meet any unforeseen need as well




Actual through 19/20 Projections through 25/26



#3 - Westmoor HS (blue)


#2 - Terra Nova HS (yellow)


Head Start

JUHSD is committed to continuing our longstanding partnership with IZZI Head Start Preschool

IZZI would like to remain at Serramonte because it is nearest their families

If no development, two solutions have been discussed:

- Remain at Serramonte and fund their own utilities and improvements, or
- JUHSD could potentially offer space at Westmoor HS



District Offices and Adult Education

- Existing facility has outlived useful life
- Maintenance and operations costs are expensive due to its inefficient design
- Current seismic, ADA, and other safety issues
- It would cost more to renovate than to build new facilities
- The District Office and Adult Education programs are not located near any of the existing school sites
- Students in our Adult Education
 Programs have unique issues that are not adequately served in the Serramonte
 Del Rey facility



New District Offices and Adult Education Facility

- Our feeder district, Jefferson Elementary School District, is located across the street
- Creates an Education Civic Center that is a convenient location for parents and staff and creates opportunities for staff to easily collaborate
- Creates a separate facility for Adult Education
- Designed to meet the specific needs of the district and community
- Located near public transportation
- 100% bond funded





- A portion of the property will be publicly accessible and will include greenspace, a new children's playground, and co-use of the basketball court, as well as a walking path with seating areas
- 6 trees are scheduled for removal but 68 trees will be planted
- Improved maintenance of the outdoor spaces
- Availability of rental spaces for community gatherings
- Electric vehicle charging stations





New District Offices

- Two-level, 30,000 sq.feet
- Can house over 60 professionals
- Provides new training facilities for teachers and staff from throughout the district
- Board room for district and community meetings

New Adult Education Facility

- Two-level, 38,000 sq.feet
- 15 standard and 2 large Adult Education classrooms
- 4 classrooms and breakout spaces dedicated to Adult Transitional Education
- Adult Transitional spaces include lifeskills training areas and will be built to meet students needs
- Administration spaces (lobby, reception, office and staff lounge), associated support spaces
- 2,600-square-foot multipurpose room for physical activity and district or community meetings
