A public hearing will be held on the question of the District conveying the Easements during the regular meeting of the Board on November 1, 2022, at 7:00 p.m., in the District's Board Room, located at Serramonte del Rey, 699 Serramonte Boulevard, Daly City, California, or as soon thereafter as practicable.

Any interested person may be heard on the matter of the District conveying the Easements during the public hearing.

These matters will be considered at such time as this agenda item is considered by the Board of the District. At the time and place of the public hearing, if no legal protest satisfying the requirements of Education Code section 17560 is entered, the Board may adopt a resolution by a two-thirds (2/3) vote of its Board members authorizing and directing the execution of the three easement deeds conveying the Easements to Daly City.

- 2. North East Entrance
- 3. South East Entrance

RESOLUTION OF INTENT TO CONVEY WATER, UTILITY AND PUBLIC ACCESS EASEMENTS TO DALY CITY AND CALLING A PUBLIC HEARING IN CONNECTION THEREWITH

WHEREAS, Section 17556 et seq. of the California Education Code authorizes the Jefferson Union High School District ("District"), by two-thirds (2/3) vote of its governing board ("Board"), to convey an easement to any political subdivision or municipal corporation of the state, to lay, construct, reconstruct, maintain, and operate water, sewer, gas, or storm drain pipes or ditches, electric or telephone lines, and access roads used in connection therewith, either with or without consideration and without a vote of the electors of the District first being taken;

WHEREAS, the District owns a parcel of real property, located at 699 Serramonte Boulevard, Daly City, California, APN 091-211-230 (the "Property"), which is the site of the Serramonte Del Rey Faculty and Staff Housing Project ("Project");

WHEREAS, the City of Daly City ("Daly City") desires to acquire (1) a water easement, generally described and depicted in **Attachment "1"**; (2) a public access easement for ingress and egress, generally described and depicted in **Attachment "2"**; and, (3) a public service utility easement, generally described and depicted in **Attachment "3"**; together with the right-of-way therefor, on, over, and under the easement areas on the Property to erect, install, construct, remove, repair, replace, maintain and use, for public purposes, any and all materials, fixtures, appliances, equipment, pipes, pipelines, necessary for the transmission, distribution and delivery of water and public utilities upon portions of the Property for the Project ("Easements");

WHEREAS, the District desires to give notice of its intent to convey the Easements to Daly City and to call a public hearing in connection therewith;

NOW, THEREFORE, the Board of Trustees of the Jefferson Union High School District does hereby resolve as follows:

Section 1. The foregoing recitals are true and correct and are incorporated herein.

Section 2. <u>Intent to Convey Easements</u>. The District declares its intent to convey the three (3) Easements to Daly City for the public purposes described herein, pursuant to terms and conditions agreed upon by the parties.

Section 3. Public Hearing. The Superintendent or his/her designee is hereby directed to give notice that during the Board's regular meeting on **November 1, 2022**, at **7:00 p.m.** or as soon thereafter as practicable, at Serramonte del Rey, 699 Serramonte Blvd, Room 223, Daly City, California, the Board will hold a public hearing on the question of conveying the three (3) Easements to Daly City. Notice of the public hearing shall be given by posting copies of this resolution, signed by at least a majority of the Board, in three (3) public places within the District, at least ten (10) days prior to the hearing, and by publishing the notice of public hearing once in a newspaper of general circulation in the District, at least five (5) days prior to the hearing. The notice of public hearing shall contain details as to how any interested person may be heard on the matter of the District conveying the Easement during the public hearing. At the time and place of the hearing, if







PUBLIC SERVICE UTILITY EASEMENT DEED

THE UNDERSIGNED GRANTOR DECLARES:

Documentary Transfer Tax – EXEMPT – Rev. & Tax. C.A. § 11922 Filing Fee – EXEMPT – Gov. Code § 6103

JEFFERSON UNION HIGH SCHOOL DISTRICT ("Grantor"), a union high school district of the County of San Mateo, State of California, owner of that certain real property located in the City of Daly City, County of San Mateo, State of California, HEREBY GRANTS to the CITY OF DALY CITY ("City"), a municipal corporation, a PUBLIC SERVICE UTILITY EASEMENT over and under that certain real property more particularly described and attached hereto as Exhibit A, and depicted on the plat attached hereto as Exhibit B ("Public Service Utility Easement"), for the right to erect, install, construct, remove, repair, replace, reconstruct, maintain and use, for public service purposes, any and all materials, fixtures, appliances, equipment, pipes, pipelines, necessary for the transmission, collection, distribution and delivery of utility services over, along, upon, under and across the parcel of real property lands of Grantor for all purposes useful or convenient in connection with or incidental to the exercise of the rights herein.

- 1. Review and control the maintenance of any improvements within said easements; and

1. Grantor shall not plant any trees or bushes within or erect, construct or install any fence, wall, irrigation or any other type of structure, improvement or private utilities over, across or under said easement without first obtaining written permission from City, which shall

not be unreasonably withheld. Grantor shall keep the easement area clear from any obstructions that will make the area inaccessible.

The conveyance of said easements is made for the benefit of all parties who have or may acquire any right, title, or interest in any part of the above described real property. This conveyance is binding on the Grantor, its heirs, assigns and successors in interest.
